- **Applicant must be State of Illinois certified Basic Firefighter.**
- **Applicant must be a State of Illinois licensed Paramedic EMT-P**

A COPY OF THE FOLLOWING ITEMS MUST BE SUBMITTED WITH YOUR APPLICATION WHEN APPLYING FOR A PART-TIME FIREFIGHTER/PARAMEDIC POSITION:

- **Valid Illinois driver's license**
- **Valid Illinois EMT-P license**
- **Valid CPR card**

Once an applicant is offered part-time employment, it is mandatory they:

- **Pass a criminal background check**
- **Complete a pre-employment physical by a District approved physician.**
- **If a paramedic, successfully gain entrance into the SCC EMS system.**
