Qualifications

- Applicant must be a U.S. citizen and at least 21 years of age (65ILCS 5/10-2.1-6.3)
- Have a high school diploma or equivalent (GED)
- Possess a valid driver's license
- Be certified as a Basic Operations Firefighter through the Office of the Illinois State Fire Marshal
- State of Illinois Licensed Paramedic (IDPH EMT-P) Required at date of hire
- CPAT certificate that includes ladder climb Required at date of hire

Applications for Firefighter/Paramedic are available for pick-up May 15 – June 16, 2023 to qualified applicants. A \$25 non-refundable processing fee (cash/check only) is due upon submission of the application. Applications are available at Station #1, 8611 S. Roberts Road, Justice, IL, and on our website: www.rpfpd.org

A completed application shall be returned to Roberts Park Fire Protection District, 8611 S. Roberts Road, Justice, IL 60458 no later than 3:00 p.m. on Tuesday, June 20, 2023. Failure to fully complete the application form shall be grounds for rejection from the testing process. Applicants must attend the following orientation prior to written test:

MANDATORY ORIENTATION: Saturday, July 15, 2023 - 0830

WRITTEN TEST: Saturday, July 15, 2023 - 0900

Station #1, 8611 S. Roberts Road, Justice, Illinois 60458. Failure to attend the orientation shall be grounds for rejection from the testing process.

ORAL INTERVIEW: TBD. Eligible candidates will be notified after a successful passing grade (70% or better) on the written test.

After the Initial Eligibility List is posted, Form E, the Preference Points Claim Form and Affidavit - (Veteran, Education, Experience, and Certifications), can be submitted by all candidates who have successfully completed the written and oral tests.

ROBERTS PARK FIRE PROTECTION DISTRICT PREFERENCE POINTS FOR FIREFIGHTER CANDIDATES

After the Initial Eligibility Register is created, candidates who are eligible for preference points may submit a claim for these points in writing to the Board of Fire Commissioners on its standard form. This claim must be made within ten (10) days after the posting of the Initial Eligibility Register or the points will be deemed waived. Applicants may claim up to three (3) types of preference points:

1. Experience Preference Points (maximum 5 points)

Any applicant who has been a part-time certified Basic Operations Firefighter, Advanced Firefighter, EMT-B, EMT-I or EMT-P for the Roberts Park Fire Protection District shall be awarded one-half point for each year of successful service, up to a maximum of five (5) points at the time of the posting of the initial eligibility register.

Any applicants from outside the Roberts Park Fire Protection District who were employed as full-time certified firefighters or paramedics for at least two (2) years at another fire protection district or municipality shall be awarded one (1) point for each year up to a maximum of five (5) points. No experience preference points will be awarded to applicants for service with a private employer who had a contract for fire or ambulance service with another fire protection district or municipality.

Proof of such service must include submission of copies of applicable certificates and a sworn affidavit signed by the applicant (see attached **Form E**). Note that proof of paid-on-call or full-time service may be verified by the District. Also note that an applicant may not receive experience preference points for a certificate if the amount of points awarded would place the applicant before a veteran on the eligibility register. Finally, no person shall be awarded more than the maximum of five (5) points for experience.

Veteran's Preference Points (maximum 5 points)

Applicants who served in the United States military actively for at least one (1) year and who were honorably discharged or are now on inactive or reserve duty shall receive five (5) points. Proof of prior service must include a copy of Military Form DD-214 (long form) as proof of active service, evidence of the honorable discharge, and a sworn affidavit signed by the applicant (see attached **Form E**) Proof of current inactive or reserve service must include the applicant's most recent Leave and Earnings Statement (LES).

3. Educational Preference Points (maximum 5 points)

Applicants who have successfully obtained an associate's degree in the field of fire service or emergency medical services, or a bachelor's degree from an accredited college or university shall receive five (5) points. A certified transcript must be included with the request for preference points as proof of the attainment of degree.

4. Additional Preference Points [70 ILCS 705/16.06b(h)(7)](maximum 5 points)

The Board reserves the right to award up to an additional five (5) preference points for unique categories based on an applicant's experience or background as identified by the Board and announced with the notice of the examination
